Transportation is available to those students who live beyond a designated area from school. Rules and regulations governing transportation are established for the operation of the school busses. Transportation is considered a service provided by the school district and all students must abide by all rules and regulations. **Students who violate rules and regulations are subject to SUSPENSION of their bus riding privileges.** Below are the bus rules and regulations. Please keep them for your reference and sign and return the second page to your student's bus driver.

Bus Rules and Regulations:

- 1. Students are required to follow the bus drivers instructions at all times**
- 2. Students must be prompt at the bus stop. Students should arrive 10 min. before** the scheduled pick up time. When crossing the roadway to meet or leave the bus, students shall wait for the bus driver signal before crossing in front of the bus and must be 10 ft. in front of the bus!
3. Students are to be **seated facing forward both feet on or near the floor.** They are not to be turned sideways, or in the aisle or facing the back of the bus. Students shall not open or close a window without permission from the driver. **No objects or body parts shall be out the windows!**
4. **There will be NO TOLERANCE for any behavior which jeopardizes the safety of the driver or passengers i.e. drugs, alcohol, smoking, vaping, exiting rear door, inflicting bodily harm, vandalism, littering or bullying of any kind!**
5. **Respect** the driver and other students on the bus.
6. Students may talk quietly while on the bus. Students must be quiet at all railroad crossings. **Foul language and obscene gestures will not be tolerated.**
7. Students **must remain seated** until the bus has come to a complete stop and the air brakes are engaged.
8. Students are **NOT ALLOWED** to have **gum, candy, or food on the bus** other than and sealable water bottle.

9. **Aisles of the bus must be kept clear** at all times. No feet, legs, backpacks, jackets etc.
10. Students are **not permitted** to take **pictures or videos** while on the bus.
11. If using any electronic device the **sound must be off**, the use of **ONE** ear bud is permitted. Students must be able to hear driver at all times!
12. Absolutely **NO SPRAYING** of any kind i.e. **hair spray, perfume, body spray, deodorant etc.**
13. Make-up and nail products are **not allowed** to be used on the bus at any time!
14. **If your student is going to have a friend ride the bus they MUST HAVE parent written consent from each parent or you may call your students school office or Evalyn Parks in transportation to give verbal consent. We will not allow any students to ride without prior permission!**

COVID- 19 Safety Rules and Precautions

Busses will be cleaned and sanitized after every route!

Hand sanitizer will be offered to every student every time they load and unload the bus.

Masks will be optional for all students; however the driver will be wearing a mask for safety precautions

Windows will be open to insure air ventilation on the bus. During this time the windows will only be operated by the bus driver.

Students with siblings must sit together whenever possible. Driver will delegate seating charts as needed.

If your child is sick i.e. fever, cough, etc., keep them home, do not send them to school please!!!
